Board Meeting in Lexington, KY August 29, 2018

The meeting was called to order at 7:03 pm (Eastern) by President Robert Newman

- Recording Secretary (Theresa)
  - Discussed the May, 2018 meeting minutes. Linda made motion to accept them, Stephen seconded the motion. None were opposed.
- Corresponding Secretary (Stephen)
  - Has received 4 requests for information
- Treasurer (Mary)
  - Total accounts data:

Checking: \$19,116.10
Savings: \$14,405.49
Rescue: \$13,621.92
Total: \$47,143.51

- Western netted \$1572.19 profit and the Easter netted \$2852.97
- National had good sponsorship but expenses coming in late. Very poor entries for National. Biggest entry was 32.
- We discussed that we are not a club that can really hold a separate National. Should consider anchoring National to Eastern one year and Western the next. Come back to this in new business.
- Procured Square for club.
- PayPal with the online store needs work to get it easy to reconcile. Square can also do online stores. We could keep a merchandise store all year.

#### Rescue

- No rescues we are taking responsibility for.
- o Florida rescue situation may be a scam. For now we will do nothing.
- Health (Stephen)
  - Reminder still going out in Scribe
  - Question asked about what members did not respond last year and who has responded thus far this year.
  - Andrea can send out a reminder email (blast) to do health survey ¾ of the way through the year.
- Education (Sheila)
  - Awards (Sheila Hoffman)
    - 9 dual titlist, 3 versatility and 1 versatility excellent.
    - The awards committee arranged for the #1 PHCA plaques this year. Many thanks to Pam Haig for starting this tradition, compiling the data, and covering the cost for so many years.
  - Judges Education (Sheila Hoffman)
    - Mailed out a few illustrated standards. We did add the illustrated standard to the PHCA website in PDF form and there has not been a request for a hard copy since that time.
    - Three judges have commented to Sheila about the on-line seminar course on the AKC website. They seem to be pleased and finding it helpful in clarifying questions they may have had.
    - Sheila will be giving the breed seminar in Orlando, FL on Wednesday, December 12 at the AKC/DJJA Advanced Judges Institute. Need 4-6 dogs for hands on portion. On August 13, Sheila received notice that there were already 30 (max allowed) signed up for the seminar.
- Challenge/Perpetual Trophies (Stephen)
  - Everything the same, no action.

# Specialties 2019

- Shawna is not planning on doing Western
- Currently we have NO 2019 proposals in our hands
- Continue to use Sue Carter to select judges
- Robert attempting to work up proposal for 2019 but we need to announce we are accepting proposals –
   Andrea to send out another email blast for proposals.
- Julie Gwin expressed interest in doing the Eastern again. Her previous Eastern was very successful financially.
- Sheila judged sweepstakes at the Curly Coated Retriever Club of America in 2016 and they offer Gun Dogs and Dual Titlist in Sweeps – may be a way to increase entries

#### Mentoring

- We discussed altering the mentor requirements at previous board meeting and Robert asked for feedback.
   He only received one response. Please send responses to Robert minimum requirements to act as mentor/do judges education.
- We have to notify AKC who is offering judges education at meeting.

## Specialty Guidelines

- We still need guidelines for specialties to help people with proposals.
- Board Member Nominating Committee
  - Mary heading
  - Andrea to send out e-blast with proposed Slate
  - Only send out ballot if there are additional valid nominations from the membership
  - Stephen, pam and Rita up for renewal. Rita sent email and has decided to step down after 45 years. She will still do education committee. Pam willing to serve or yield.
  - Motion made by Mary to approve nominating committee and alternates and to have Slate finalized by September 30 to be e-blasted to membership by October 1. Theresa Seconded, all approved.

### Old Business

o Pharaoh Hounds getting approval for herding. Apparently other breeds did not want Pharaoh Hounds.

#### New Business

- Robert made a motion to anchor National with Western one year and Eastern the next as we don't have the numbers to support 3 specialties a year. Linda seconded. All were in favor, none opposed. Preference will be for the West Coast in 2019.
- o Robert wants to establish a new award: The PHCA Legacy Award.
  - Not necessarily an annual award
  - Given to those that demonstrate commitment to the breed over many years.
  - Pam Haig as inaugural recipient
  - Firm up rules at later date
  - Can be given posthumously
  - Approval by a majority of the board
  - This award is in compliance with AKC awards
  - Robert made the motion to establish the legacy award to be awarded as deemed qualified and subject to approval by a majority of the board. Stephen seconded. All approved.

### Delegates Report (Dominic)

- Lure coursing is up 13% YOY, FAST CAT is up 169% YOY, CAT down 4% YOY
- The Museum of the Dog will have one of the best art collections of dog art in the world. It is 1.5 blocks from Grand Central Station.
- Purebred dog organizations are being targeted. There were 2100 anti-dog legislation bills in 2018.
- New initiatives
  - Service dog intitiative to help stop fake service dogs. In conjunction with the airlines and the government.
  - AKC bomb detection dog intitiative 80-90% of dogs are failing out of training. We get
    most of these dogs from Europe and they are keeping the higher quality dogs in their own
    countries.

 Dominic suggested we make a one-time payment to the Museum of the Dog to have a PHCA plaque in perpetuity – cost is \$2500. Can be paid over 5 years. Andrea made a motion to do the one-time payment and Robert seconded. All were in favor.

Theresa moved to adjourn the meeting, Linda seconded the motion. It was unanimously approved and the meeting was adjourned.
