The meeting was called to order at 5:33 pm (Pacific) by President Mary Severino.

Meeting Minutes

• Theresa Harper made a motion and Lynne seconded to approve April meeting minutes. All were in favor. Meeting minutes were approved.

• President's Update (Mary)

o General:

• For the past few weeks, I have been focused on two primary areas, the Treasurer transition and the AKC Meet the Breeds. I have submitted a 'President's Message' to Darleen Dimor for inclusion in the upcoming Scribe that I attached to this report.

Treasurer's Transition:

Luciane will provide the update in this month's Treasurer's Board Report. I completed tasks through the first quarter and until Luciane was able to fully perform the treasurer duties. We will continue to work in tandem to improve treasurer transition issues for the future. If/when financial questions or needs arise, Luciane is the primary contact for the Board.

Committees and Structure:

Rebecca Stephens has been following up on her work with committee structuring and I
have utilized her in determining the appropriate individuals to engage in various
discussions, issues or needs that arise for the club.

Rescue:

There has been follow-up on the Luna surgery that the Board discussed over the course of the month. Theresa Harper and Luciane will provide an update as appropriate. I followed up on the Board's recommendation to obtain information about establishing corporate separation, a 501 (c) 3 charity, for our rescue activities. I talked with friends in The American Whippet Club who set up a separate corporation for their rescue activities under the name WRAP (Whippet Rescue and Protection). Jennifer Beach-Buda, who runs much of their business, forwarded me WRAP's Constitution and bylaws for our review with a strong recommendation in favor of our moving forward. Their organizational issues are controlled with QuickBooks and PayPal, systems that we currently have in place for the PHCA. I will garner further information and will update the Board.

PHCA Annual Audit:

PHCA's 2020 books have been reconciled and are ready for the Audit Committee's annual review. Linda Witt was nominated as the Board's Audit Chair in April's Board Meeting. Since she was unable to attend that meeting, we need to confirm that she is willing to accept that role.

PHCA Online Store:

Shortly after our April Board Meeting and following a message to the membership that the online store was 'live,' we had sales grossing an impressive amount for our specialties. The interest following the e-blast emphasized both the value and the importance of frequent promotion of the specialties and the online store.

Bylaws Committee:

 No updates since last month. I hope to bring the committee back into action this coming month.

Recording Secretary (Theresa)

- Waiting on return of ballots for Kendra Williams application. I have 6 thus far.
- Preferred judges ballots have to be postmarked by May 15. I have received a number of ballots thus far but expect to see more in the next couple of weeks.

Treasurer Position Transition

Mary Severino and I continue to work on the Treasurer transition. Currently, I have access to all key systems: QuickBooks, Wells Fargo, PayPal, and Square. However, access levels are still being adjusted. Wells Fargo access level will require approval by the Board. I will suggest language for discussion ahead of our next Board meeting. Mary has prepared the Q1 Treasure report for the Scribe.

April not closed yet due to issues with the transition. Luciane will look at banking changes with an eye towards easier transitions in the future.

Rescue

Luna, one of the two 8 years-old rescue females in New Jersey (previously in Florida), had an eye removal surgery on Friday 5/14/2021. Rescue is covering the eye removal: \$699.50 with \$300 previously donated by Karin Robbins specifically for the care of Luna and Zorra rescue efforts.

PHCA Online Store

Following the 4/19/2021 PHCA email on trophy sponsorship, there was some good activity on the PHCA store (over \$1,600). The increase in Wells Fargo checking account observed in April was driven by trophy sponsorship. However, within days the store went completely silent. The last transaction was completed on 4/24/2021. Additional advertisement is essential.

Committees (Rebecca)

"The PHCA Board of Directors has been working on our club's committee structure this past year, creating some new committees, and aligning all committees, new and existing, with a structure that will facilitate communication between committees and the Board of Directors and other committees and subcommittees. We are pleased to announce to our members the full list of PHCA Committees and Subcommittees, along with the committee liaisons who serve on the PHCA Board of Directors. Each committee has a PHCA Board Liaison who serves as a contact person for their designated committee(s). Each committee also has or will have a Committee Chairperson and when possible, a Committee Co-Chairperson. Each subcommittee also has a Subcommittee Chairperson, and the Subcommittee Chairs will communicate primarily with their Committee Chair.

We encourage PHCA members in good standing to review the list of committees and subcommittees and, if you are interested in serving on a committee, please contact the Committee Liaison who is listed for that committee before 6/30/2021. Their email addresses

are provided. Please communicate your interest with the Board Liaison for that committee, since at this stage, the Board Liaisons are the individuals who are coordinating their respective committees development.

The Committee Liaison will then forward the information of your interest to the appropriate committee chair for follow up contact.

Please note that this is an important first step in our process of committee development. After members are able to communicate their interest in specific committees, we will better be able to proceed with finalizing committee chairs, co-chairs, and members, and can then more effectively communicate that updated information to members as well.

The strength of any organization is reflected in the commitment and involvement of its members, and we hope that you will find this list to be helpful to you in connecting with opportunities for involvement with the PHCA."

The following is a proposal for how the PHCA will structure its committees and subcommittees and communications with committees:

PHCA Committees

- 1) As per the PHCA By-Laws, standing committees are created and appointed by the PHCA Board of Directors (Article VI, Committees, Section 1.) Appointments may end or be terminated as per the process established in the PHCA By-Laws.
- 2) Each committee shall have one committee chairperson and a co-chair. The chair of a committee shall be appointed and approved by the PHCA Board of Directors. Current PHCA members in good standing may notify the board of any interest that they may have in serving as a committee chair. Subcommittees shall have one subcommittee chair, appointed and approved by the Board of Directors.
- 3) Each committee and subcommittee shall have the opportunity to have committee members, as appropriate, and those committee members will be current PHCA members in good standing. Committee and subcommittee members shall be appointed and approved by the PHCA Board of Directors and the committee chair.
- 4) Each committee shall have a committee liaison who is a current member of the PHCA Board of Directors, and who will serve as a resource and communication person between the committee and the Board of Directors. Subcommittee chairs shall communicate with their committee chairperson.
- 5) Each year, in January, the PHCA Corresponding Secretary will send out an email to all current PHCA members in good standing inviting members to contact the Committee Board Liaison to indicate an interest in serving on a committee or committees. The Board Liaison will then compile a list of all interested members, communicate that list to committee chairs, and submit that information to the PHCA Board for approval.
- 6) The following is a list of proposed PHCA committees and subcommittees. Those designed with asterisk * are proposed new committees or sub-committees, or represent a new placement within the committee/subcommittee structure.

Each committee will also have a designated co-chair to assume responsibilities if the committee chair is at any time unable to serve in the chairperson role.

 Zora is recovering from her spay. Both will likely be adopted be their foster Shenandoah.
- Penny (was jewel) is in Illinois. Christine is still deciding if she will adopt her. Likely yes.
 Suspicious lump dissipated on its own and she's still getting treatment for hookworm.
- Once the committee is notified about a potential rescue, the rescue committee should nominate someone to see the situation through until the end. Otherwise, the situation can fall through the cracks.
