#### Summary

- In beginning of August, a fraud cause led to the freeze and later closure of the prior check accounting (ending 4224) and opening of a new check accounting (ending 4891). The checking account funds were automatically transferred, and, after investigation, the funds involved in the fraud were refunded.
- Account information for the old checking account (ending 4224), including statements and documents, will only be available for approximately 90 days. While the account

number has been updated in other systems to avoid interruption of any service, old statements still need to be downloaded to ensure appropriate record is kept.

- The PHCA received 1 membership application fee through PayPal. Waiting for check to arrive for other recent applications.
